



Hartford – Federal Funding Snapshot

Total Funding: Over \$1 billion

- **\$210 million** in indirect American Rescue Plan (ARP) funding
- **\$270 million** for a new Federal Courthouse
- **\$224 million** in Federal Infrastructure funding
- **\$76 million** in Federal Historic and Low-Income Housing Tax Credits
- **\$180 million** in Federal Grants
- **\$22 million** in Earmarks

American Rescue Plan Act (ARP) Funding:

- The City of Hartford has received more than **\$210.7 million** in **ARP** funding for local priorities, including:
 - **\$13.9 million** for after-school programming support and youth-led community service initiatives
 - **\$7 million** for housing nonprofits to renovate and improve blighted buildings
 - **\$11.25 million** to fund violence prevention programs and reentry nonprofit organizations
 - **\$62.6 million** for small business support and community development projects, such as Hartford Public Library construction projects at the Barbour Street and Albany Avenue branches, warehouse revitalization projects

throughout Parkville, and downtown storefront development efforts to attract small businesses to the city center

- **\$5.85 million** to support public art and music offerings for Hartford residents
- **\$15.5 million** for 42 Hartford restaurants to remain open and operational
- **\$80k** for local museums and libraries to maintain services through the pandemic
- **\$5.9 million** to purchase and distribute laptops and remote learning technology to Hartford students
