RESOLUTION

Of inquiry requesting the President and directing the Secretaries of the Treasury, Labor, and Health and Human Services to transmit, respectively, certain documents to the House of Representatives relating to the development of a centralized database by the Federal government and Palantir Technologies Inc. that compiles American citizens' personal information across Federal agencies and departments, including confidential taxpayer, iden-

1 *Resolved*, That the President of the United States is
2 requested, and the Secretaries of the Treasury, Labor, and
3 Health and Human Services are directed, to transmit, to
4 the extent that such documents are in the possession of
5 the President or the Secretaries, to the House of Rep-
6 resentatives, not later than 14 days after the date of adop-
7 tion of this resolution, copies of any document, record,
8 audio recording, memorandum, call log, correspondence
9 (electronic or otherwise), activity log, audit trail, audit log,
10 written agreement, contract or contract solicitation, em-
11 ployment document, payment record, or other communica-
12 tion or any portion of any such communication, that refers
13 or relates to the following:

14 (1) The development of a centralized database
15 by the Federal government and Palantir Tech-
16 nologies Inc. that compiles American citizens' per-
17 sonal information across Federal agencies and de-
18 partments, including confidential taxpayer, identity,
19 wage, child support, bank account, student loan,
20 health, medical, financial or other information pro-
21 vided to or collected by the Social Security Adminis-
22 tration, the Internal Revenue Service, the Depart-
23 ment of the Treasury, the Department of Health
24 and Human Services, the Department of Labor, or

1 any State or county government, in response to a re-
2 quirement by one of such entities.

3 (2) The purpose and potential uses of a central-
4 ized database, including whether it will be used to
5 conduct Federal tax audits and investigations, con-
6 duct Federal criminal investigations, restrict or deny
7 Social Security benefits, restrict or deny Medicare
8 coverage, or sell or make available information for
9 private purchase.

10 (3) Services provided by Palantir Technologies
11 Inc. to the Social Security Administration, the Inter-
12 nal Revenue Service, the Department of Labor, the
13 Department of the Treasury, or the Department of
14 Health and Human Services under any sole source
15 contract that lacked a competitive bidding process or
16 under any indefinite delivery or indefinite quantity
17 contract.
